Tuition Payment:

Summer Camp tuition for each student is to be paid in full by May 23, 2019. Camp tuition is not refundable.

Attendance/Tardiness:

Camp attendance is not mandatory for Little Stars or Pre-Professional Camps, however tuition is not prorated for missed days of camp. Performers need to be in attendance for the entire ACT Summer Stock Program. Any performer who misses an ACT Summer Stock camp day will be removed from the production. No refunds will be given for tuition.

Code of Parental Responsibility:

It is the responsibility of the parent/guardian to be aware of all ADA performances, cancellations, events and costume requirements. Information will be e-mailed as well as posted at the Studio. It is the parent/guardian's responsibility to regularly check e-mail and/or Studio postings and read information thoroughly. No student handouts will be given. It is the parent/guardian's responsibility to inform ADA of any address, e-mail address or telephone number changes.

Cell Phone Policy

Cell Phones are not permitted in the studio at any time. Students may utilize the studio phone should a parent or guardian need to be contacted. Students in violation of the Alipne Dance Academy Cell Phone policy will be expelled from the program.

Dress Code

Leotard and tights are required for Shining Stars and Pre Professional Camps, as well as all dance footwear. Students may arrive early on Monday of camp to utilize shoe swap. ACT Summer stock participants should dress in active wear. No jeans, no bare legs, no bare mid-drift. Leotard and tights are recommended for ACT Summer Stock participants, but it is not required.
