Once you have read all the enclosed information, and your performer agrees to performance requirements, please tear off signature portion and return to ADA. If your signed slip is not received by October 1, 2019 your dancer will be withdrawn from Kindred Spirits preparations and choreography.

**Once a dancer is committed to the Kindred Spirits, any other activities that should arise during Dress Rehearsal or Performance times should be politely declined. Please present this commitment to all of your dancer's other activities, so coaches and leaders are aware of this commitment up front.**

## **Saturday November 2nd: MANDATORY DAY**

Dress Rehearsal at the Riverwalk Center in Breckenridge

10:00 am - 3:00 pm for **ACT Company members**

12:30 pm - 3:00 pm for all **dance performers**

- ~ **Dance performers** must wear all black, dance wear is preferable. Costume accessories will be provided on site. **ACT Company members** will be responsible for all their own costume pieces.
- ~ Hair and makeup will be done upon arrival! Please bring a brush, hairspray & bobbie pins so we can transform you into character back stage.
- ~ Face painting is very common for Kindred Spirits, please alert us ahead of time if you do not wish your dancer's face to be painted.
- ~ No visible piercings, tattoos, jewelry or nail polish is permitted.
- ~ Phones are not permitted at dress rehearsal or the show.
- ~ **No parents are allowed backstage.** Parents may get dancers performance ready in the audience. Once dancers are performance ready, they may head backstage for the remainder of the day.
- ~ This is an open rehearsal, anyone is welcome to watch.
- ~ **In accordance with live theatre copyright production laws, no photography or videography is permitted at any time (dress rehearsal or the performance).** This is a law we take very seriously, and we could lose our licensing if there is any violation. Phones or cameras will be **confiscated by ADA staff.**
- ~ All performers will be finished rehearsing by 3:00 pm. Dancers will have a snack break at 3:00 pm while ADA staff clears the house of all persons and personal belongings left behind at dress rehearsal (no seats may be reserved for any ADA performance). Once the house is clear, the box office will open. Dancers will stay backstage at the Riverwalk to eat. Dancers will need to bring a packed snack and a change of clothes to eat in during dress rehearsal.
- ~ Water is the **ONLY** food or beverage item allowed backstage during the performance! Food will **ONLY** be accessible during the 3:00 pm snack break.

## **Saturday November 2nd: MANDATORY DAY**

Performance: 4:00 pm at The Riverwalk Center in Breckenridge

~ Performers will be at the Venue already, due to dress rehearsal. No parents are allowed backstage. House will be cleared of all persons and belongings after dress rehearsal (no seating requests or reservations are accepted at any ADA performance).

~ Doors Open at 3:00 pm (or as soon as house is cleared from Dress Rehearsal).

~ Performance begins promptly at 4:00 pm

~ All dancers will remain backstage for the entire show

~ **No parents or audience members are permitted backstage.**

~ **In accordance with live theatre copyright production laws, no photography or videography is permitted at any time (dress rehearsal or the performance). This is a law we take very seriously, and we could lose our licensing if there is any violation. Phones or cameras will be confiscated by ADA staff.**

~ Bar and concession services will be provided by the Riverwalk Center.

~ Admission: \$15 Adults, \$10 Students, Children 4 and under are admitted free (All audience members pay admission to the performance.)

~ Admission is to be paid by cash or check only.

~ Seating is first come first serve, no advanced ticket sales or seating requests are offered for Kindred Spirits. The audience will be cleared in between Dress Rehearsal and the Performance. All audience members will enter and choose seating no earlier than 3:00 pm.
